The main translations are from Tyndale translation, from the Geneva Bible, Douay-Rheims version, and from the King James version. I will be going over the main translations of the Bible, the problems of the translations, and its overall effect on societies. Tyndale did not work entirely from the Vulgate Bible.

Tyndale worked with pieces of translations of the Vulgate Bible, but definitely not entirely. The Vulgate is a late 4th century Latin translation of the Bible that became the Catholic Church's official Latin version of the Bible during the 16th century. "The Geneva Bible is an early English translation of the Bible.

and even after the King James Version was published in 1611. For some forty years after the King James Version was published, the Geneva Bible remained the most popular English translation of the Bible.”(.

.) “ The Douay Rheims Bible was translated in the 16th century from the Latin Vulgate of St Jerome, a text that was declared authoritative for Catholics and commonly known as the purest text available at the time. The Douay-Rheims translation is the one most often used in Latin Missals.

” Lastly, the King James version is an English translation of the Christian Bible for the Church of England that started in 1604 and completed in 1611. The Bible is actually many works passed down from author to author translating works from different languages, discrepancies, and copies that are not original. These copies were extremely inaccurate since they were handwritten and had a lot of errors in them. Language is also a huge problem in trying to translate . A big problem was that certain words and phrases in a language have no exact correlation in another language. Not having the original documents makes the translation way more difficult since you do not know how accurate the translation will be. You are pretty much guesstimating about what the documents are saying due to inaccuracies.
