I feel that Friar Lawrence has to be examined more closley. His actions at times are very extraordinary to say the least. Not only does he know about the secret love affair he also knows about the family background and lack of peace behind it. However, he comes up with the catastrophic idea. Totally unaware of the consequences. He provided the lethal drug, which in the end took Juliet's life. In addition, he could not handle the guilt on hearing that Juliet had passed away.
