Abstract

Summary

All the patients underwent about fifteen months of treatment.

Based on the result of the study, alteration in the anaclitic patients transpired mostly in more pathological types of mental disarray, which can be characterized by confabulations and contaminations, which articulate border disorders. changes, but this happened mostly in less distressed thought disarray which conveys inclinations toward referential thoughts (Blatt, Besser & Ford, 1-9).
